Preparation for Treatment:

Please ensure that the unit is prepared for treatment upon the technician's arrival. We ask that you be mindful of the technician's time, as well as the other residents waiting for treatment. Technicians cannot wait, so if you are not prepared, the treatment will be canceled, and a cancellation fee will apply.

Mandatory Evacuation Period:

All adults and children

All individuals and pets must vacate the premises for a minimum of FOUR (4) hours after treatment. Individuals with allergies, respiratory issues, or who are pregnant should vacate for at least **SIX (6) HOURS.

Caged Pets Protocol:

Remove any birds and other caged pets (including fish and reptiles) from the residence during treatment. For fish tanks, turn off pumps and filters, and cover the tank with plastic wrap. Wait **24 hours** before reintroducing exotic animals.

HOW TO PREPARE

PRIOR TO TREATMENT

Locate Breeding Sites

Check sinks, drains, and areas with moisture for signs of drain fly activity. Look for adult flies resting on surfaces or larvae in the organic sludge found in drains.

Inspect Nearby Areas

Examine areas where organic material might accumulate, such as garbage disposals, floor drains, and kitchen or bathroom sinks.

Clear the Treatment Areas

Remove Obstructions

Clear any items from around sinks and drains to provide easy access for the exterminator. Moving dishes, cleaning supplies, and any furniture away from the area can be helpful.

Clean Up Spills and Debris

Clean any food spills, crumbs, or debris that may attract flies, especially in kitchens and dining areas. Plan for Pets and Children

Relocate Pets

Keep pets away from treated areas during the extermination process to ensure their safety.

Child Safety

Ensure that children are kept away from treatment zones until the exterminator confirms it is safe to return.

Provide Observations

Share any details regarding the locations of drain flies, including when you first noticed them and any previous methods attempted for eradication.

Pre-Treatment Instructions

Clean Drains

If possible, before treatment, clean the affected drains using a pipe brush or a drain cleaner to remove organic buildup. This can help enhance the effectiveness of the treatment.

Close Windows and Doors

Ensure that all windows and exterior doors are closed before treatment for optimal results.

Mandatory Evacuation Period:

All adults and children

All individuals and pets must vacate the premises for a minimum of FOUR (4) hours after treatment. Individuals with allergies, respiratory issues, or who are pregnant should vacate for at least **SIX (6) HOURS.

Caged Pets Protocol:

Post-Treatment Guidelines

Mandatory Evacuation Period:

Caged Pets Protocol:

Monitor for Activity

After treatment, check the areas for any signs of continued drain fly activity. If you notice any new activity, contact us immediately for follow-up evaluation.

Cleaning

Do not vacuum for 7 days after treatment.

Vacuum every 3 days after that.

No Pesticides or Cleaning Products

Do not spray any pesticides or cleaning products in treated areas after the treatment, as this may lead to control failure.
