PRIOR TO TREATMENT

Preparation for Treatment:

Please ensure that the unit is prepared for treatment upon the technician's arrival. We ask that you be mindful of the technician's time, as well as the other residents waiting for treatment. Technicians cannot wait, so if you are not prepared, the treatment will be canceled, and a cancellation fee will apply.

Mandatory Evacuation Period:

All adults and children

All individuals and pets must vacate the premises for a minimum of FOUR (4) hours after treatment. Individuals with allergies, respiratory issues, or who are pregnant should vacate for at least ****SIX (6) HOURS**.

Caged Pets Protocol:

Remove any birds and other caged pets (including fish and reptiles) from the residence during treatment. For fish tanks, turn off pumps and filters, and cover the tank with plastic wrap. Wait ****24 hours**** before reintroducing exotic animals.

Identify Infested Area

Locate Activity

Look for signs of infestation in your pantry, such as adult bugs, larvae, webbing, or holes in food packages. Check areas where dry goods are stored, including shelves and cabinets.

Inspect Food Products

Pay attention to dry food items like grains, flour, rice, nuts, dried fruits, and cereals. Inspect packages for damage or signs of pests.

Clear the Treatment Areas

Remove Infested Food

Discard any infested food items in sealed bags to prevent spreading the pests to other areas. Ensure you check all containers, including those that may be hidden in the back of shelves.

Clean Shelves and Cabinets

Empty the pantry shelves and thoroughly clean them with hot soap and water to remove food residues, droppings, and any eggs or larvae.

Store Remaining Food Properly

Use Airtight Containers

Transfer any remaining non-infested food items into airtight containers to prevent pantry bugs from accessing them in the future.

Dispose of Expired Items

Check expiration dates and dispose of any old or unused food products that might attract bugs.

Follow Pre-Treatment Instructions

Remove Food Items: Take all food items out of cabinets and shelves, including canned goods, to ensure a thorough treatment.

Clear Adjacent Areas: Move nearby furniture or appliances (if applicable) to provide access for the exterminator to check for bugs that may have spread to other areas.

Post-Treatment Guidelines

Mandatory Evacuation Period

Cleaning

Avoid cleaning inside of kitchen cabinets corners for 14 days.

Monitor for Activity

After treatment, keep an eye on your pantry for any signs of renewed activity or infestation.

Prevent Future Infestations

Regular Inspections

Conduct routine checks of pantry items and storage areas to catch any signs of pantry bugs early.

Maintain a Clean Environment

Regularly clean pantry shelves and immediately address any spills or crumbs to deter pests.

Proper Food Storage

Store food in airtight containers and practice healthy food hygiene to minimize attractants for pantry bugs.

No Pesticides or Cleaning Products

Do not spray any pesticides or cleaning products in treated areas after the treatment, as this may lead to control failure.
